Timeline and general description of services:

In accordance with the requirements outlined in the Request for Proposal for a Meals Program 2009-2010, Mom's Catering, Inc. ("Mom's Catering") agrees to provide Catering Services of meals that will be delivered daily and the consumable supplies and the necessary equipment for food service operation to the Jacksonville Lighthouse Charter School, effective July 1, 2009 and ending June 30, 2010. The price per cold breakfast is \$1.25; breakfast-to-go is \$1.25; hot breakfast is \$1.25; lunch is \$3.00. Mom's Catering agrees to provide meal service in accordance with the Lighthouse Academies Wellness Policy (see attached). Mom's Catering menus will use Group IV Traditional Meal Patterns for each grade level. Furthermore, Mom's Catering agrees that menus will have less than 30% of calories from fat and 10% of calories from saturated fat as dictated by the United States Department of Agriculture ("USDA") and the Arkansas Department of Education. Mom's Catering shall provide menus to the Jacksonville Lighthouse Charter School two weeks prior to the beginning of each month.

so that the school's wellness committee can review menus and respond to Mom's Catering with any necessary changes. All substitutions, should there be any, must be in compliance with the Wellness Policy and USDA requirements with advanced notice provided to the Jacksonville Lighthouse Charter School.

Jacksonville Lighthouse Charter School maintains the right to change the type of meal service based on the needs of its student population with written notification.

In addition, Jacksonville Lighthouse Charter School and Mom's Catering agree to the following:

1. Mom's Catering guarantees complete satisfaction with its services hereunder.
2. Mom's Catering will issue invoices weekly. Payment terms are net invoice amount within thirty (30) days of the invoice date.
3. Notwithstanding any of the foregoing items and conditions, in the event that either party, in the exercise of its reasonable judgment, is not satisfied with the other's performance under this contract such party shall have the right to terminate this Agreement upon thirty (30) days prior written notice.
4. All information provided by Mom's Catering is considered to be confidential and proprietary. This information cannot be divulged without prior written approval of Mom's Catering.
5. This contract shall be considered fully executed once the parties have signed this contract and has been approved by the Jacksonville Lighthouse Charter School and the Department of Education, Division of School and Community Nutrition Programs
6. All equipment supplied by Mom's Catering must meet the state department of health inspections and must maintain the specified temperature range of what the equipment is intended. If any equipment needs maintenance Mom's Catering will immediately service the equipment.
7. Mom's Catering must maintain the serving area to ensure compliance with the Department of Health, USDA, and the Arkansas Department of Education Standards.
8. Background Check. State Law mandates that if you perform work at a public charter school, it is required that all employees working for or on behalf of your company shall have a criminal background check performed. Any such employees who have been convicted of a felony offense, a drug or weapons related offense, a sexual assault offense or a crime against children shall not be allowed on school grounds.
9. Tobacco Use Prohibited. The use of tobacco products are prohibited on school property at all times.

Exceptions to RFP:

Section XII (B) Mom's Catering service will provide equipment consisting of Steam Tables, Milk coolers and any other necessary equipment needed to serve quality meals.
