Goal 1: How will the LEA foster effective parental involvement strategies and support partnerships among school, parents, and the community to improve student achievement?

JLCS will ensure there are PD opportunities for staff to include no less than 2 hours, which may be included in the minimum numbers of hours of professional development required annually, of professional development designed to enhance teacher understanding of effective parent involvement strategies. Lighthouse Academies requires 160 hours of PD yearly. Our surveys reveal that that parent teacher communication is good but we still need to work on being more consistent building wide.
